
Separation of Duties (SoD): An Overview and Methodology

What is Separation of Duties?

Separation of Duties (SoD) is an internal control concept that helps organizations prevent fraud and errors by ensuring that no single individual has the ability to both authorize and execute a transaction.





In other words, SoD requires that different individuals be responsible for different parts of a transaction. For example, one person may be responsible for approving a Free Download Free Download, while another person is responsible for fulfilling the Free Download.

Why is Separation of Duties Important?

SoD is important because it helps to prevent fraud and errors by:

- Making it more difficult for individuals to hide their mistakes
- Improving the accuracy and reliability of financial reporting

How to Implement Separation of Duties


